ANNUAL REPORT.

IST SEPTEMBER, 1902.

MR. PRESIDENT AND GENTLEMEN,

In presenting to you the Twenty-second Annual Report, your Committee are pleased to congratulate the members on the excellent position which the Club at present occupies. Both financially and in numerical strength the Club has attained a position which is without parallel.

Your Committee are proud to congratulate the Club in securing two championship races.

All through the season the greatest enthusiasm was evinced amongst the members, both in regatta and club races, and in the social fixtures your Club held; and the prospects for the coming season (1902-3) look particularly bright and attractive.

We started the season with a credit balance of £11 3s. 1d., and closed with a credit balance of

£4 19s. Id., after paying the sum of £66 in part payment of extension to Boathouse.

INTERSTATE RACE.

The Interstate Eight was rowed at Port Adelaide on 10th May, 1902, and resulted in a win for Your Club had the honor of having three of its members in the crew, namely, Messrs. A. B. Sloan (6), M. K. Moss (5), and P. C. Ivens (bow).

V.R.A. CHAMPIONSHIP RACES.

CHAMPIONSHIP SCULLS, rowed on the Lower Yarra on 26th October, 1901.—The entries were Mr. P. C. Ivens, of your Club, and Messrs. A. Chamley and C. Stamper, of the Albert Park. The race resulted in a splendid win for your representative by three lengths from Chamley. The Committee heartily congratulate Mr. Ivens on his well-merited success.

CHAMPIONSHIP FOURS.—This race was rowed on the Lower Yarra on the 30th November, 1901. Entries were received from the Ballarat, Albert Park, Banks, and your Club. This race provided a splendid struggle, and resulted in a magnificent win for the Mercantile crew, who finished a couple of lengths ahead of Ballarat, with the Albert Park placed third. The Committee have to congratulate the crew on their brilliant victory, which was gained by sheer grit and determination. A special word of praise is due to Mr. M. K. Moss, who rowed No. 3. REGATTA EVENTS.

Aylwin (bow), who won both heat and final after a hard go, but were disqualified for borning. Junior Pair—R. F. McLeod (stroke) and H. Brasch (bow), who were unsuccessful. Maiden Sculls—C. E. Edwards and H. J. Whiting, who were unsuccessful. Senior Four—A. B. Sloan (stroke), M. K. Moss (3), W. Potter (2), and P. C. Ivens (bow), who won easily. Senior Pair—A. B. Sloan (stroke) and P. C. Ivens (bow), who won easily.

The Nagambie Regatta was held as usual on Boxing Day, and the following crews represented your Club:—Maiden Eight—The same crew as at Melbourne represented the Club, and were beaten in the heat by Ballarat. McLeod (4), C. Hazard (3), F. Wilkins (2), and E. H. Muir (bow), who won heat, but were beaten in final.

The Ballarat Regatta was held on the 28th February, 1902, and this ideal racing course again attracted

large entries. Your Club were represented by Maiden Sculls-H. Brasch, who won easily at his first attempt. Maiden Eight-Same crew as at Upper Yarra Regatta, who were unsuccessful. Junior Sculls-H. Brasch, who was unsuccessful. Maiden Pair—Same crew as before, who lost. Senior Eight—A. B. Sloan (stroke), J. Southern (7), W. Potter (6), M. K. Moss (5), R. F. McLeod (4), C. Hazard (3), F. Wilkins (2), and P. C. Ivens (bow), who lost. Senior Pair—A. B. Sloan (stroke) and P. C. Ivens (bow), who were

unsuccessful.

The Barwon Regatta was held on the 8th March, 1902. Your Club competed in the following events.: -Maiden Four, who lost, and Maiden Sculls, H. Brasch, who again won in good style, thus pulling off the double.

During the season your Club competed in 26 races, winning 8, and losing 18.

CLUB RACES.

These events once more proved a great draw, and can be regarded as one of the most satisfactory of the Club's successes. The entries have been uniformly large, and, as is usual in races of this nature, the finishes were in the majority of instances close and exciting. The interest has been maintained throughout the season, and the honor of winning the Captain's Trophy for the Member gaining the highest points proved a great incentive. So evenly and keenly were these events contested, that the ultimate result eventuated in a dead heat between Mr. J. J. Fogarty and Mr. A. Cornish, with 13 points each. The opening Club Races for the season were held on the 9th November, 1901, with SCRATCH FOUR-OARED RACES for a trophy presented by Mr. H. Brasch. Excellent entries were received, eight crews competing, and some close racing resulted. The final was won by Messrs. R. F. McLeod, E. Cameron, B. Loel, and A. Bernadou. Occasion was taken to hold, in conjunction with the Yarra Yarra Rowing Club, a combined Ladies' Day. Fine weather prevailing, a very pleasant afternoon was spent.

SCRATCH PAIRS were held on the 11th January, 1902, for trophies presented by Sir Alexander

Peacock, and being favoured with fine weather and large entries, some excellent contests resulted. The final heat was the best race of the day, and resulted in a win for Messrs. A. Cornish and A. Moore by one foot from A. Bernadou and C. Bowen.

SCRATCH FOURS were held on the 18th January, 1902, for trophies presented by Messrs. F. S. Gibbs and J. Southern. Excellent entries were again received, no fewer than forty-four members competing. A HANDICAP SCULLING RACE was held on the 25th January, 1902, for a trophy presented by Mr.

The concluding Club Race was held on the 26th April, 1902, when the Morell Trophy was rowed off in Scratch Pairs. This event is always very popular amongst the members, and an excellent entry resulted. The Medals were won by Messrs. J. J. Fogarty and A. E. Hoof.

COMBINATION FOURS.

The Club once more took advantage of a generous donation by Cr. S. J. Morell to hold Combination Fours on 1st February, 1902, for trophies valued at £8 10s. Entries were received from all the metropolitan clubs, and totalled 100. The sport was thoroughly representative, and attracted a large crowd, who watched the racing with evident interest, and the race was in every way a successful fixture. The finishes were exceptionally close, three dead-heats resulting during the afternoon. The winning crew were—Messrs. Ross (Civil Service), Moses (Mercantile), Fogarty (Mercantile), and Young (Yarra Yarra).

A clinker racing scull and a practice eight are now in the course of construction, and will be ready for

use at the commencement of the coming season.


