To the Members of the Mercantile Rowing Club,

Gentlemen,

Your Committee has pleasure in presenting to you the Forty-

Ninth Annual Report.

From all aspects the season can be described as a very successful one, and the co-operation of members, coaches and officials in achieving the success has been a feature of the season.

In rowing, your Club has regained its prominent position, while, socially, you are catered for by a body of enthusiasts whose object in maintaining the social interest of members throughout the season, and the improvement of the Club's finances, has been entirely successful.

The number of applications for membership has been even greater than last season. The election of more than 70 members has fully taxed the capacity of our fleet accommodation, and those who have

assisted in their coaching. The number enrolled is a record.

It will be noticed, by glancing at the lists of your representatives at the different regattas, that large entries were sent from your Club to practically every fixture throughout the season. At each of three regattas two Maiden Eights represented the Club, two of which were successful. At each of six regattas two Maiden Fours were entered, one of which was successful, while, at Nagambie, three crews from the Club competed in the Junior Fours, one of which won that event.

It can be realised from the above that every effort has been made to achieve prominence in the Junior Premiership Competition, while, at the same time, your Senior crews were busily occupied in gaining

the honours in that division.

The outlook for the coming season was never more hopeful, and, providing that the same measure of co-operation is received from all sections as has been given in the past season, the Club's fiftieth year

should be its most successful one to date.

Great praise is due to Mr. J. G. Sprigg, your past Captain, for the able and enthusiastic manner in which he has conducted the affairs of the Club during his term of office. While he was actively and successfully engaged in rowing in the Senior ranks during the regatta season, he, nevertheless, devoted much time to the requirements of less experienced members, as well as the numerous other duties connected with his office. Your Club's present satisfactory position is very largely due to Mr. Sprigg's efforts, and we convey your good wishes that his tour will be a pleasant and successful one.

Further improvements to the river bank have been effected by the City Council during the year, with the result that the surroundings to your Club House are yearly becoming more attractive. We express

our appreciation of the Council's interest.

Finance.

The Revenue Account and Balance-Sheet show the finances to be in a highly satisfactory condition. The capital has been augmented by the sum of £222, and this, in spite of the fact that depreciation to the extent of £186 has been written off the boats, oars and sculls. The conservative figure at which the fleet now stands, £1,242, represents a considered and careful valuation.

Upon the completion of the boat building programme early in the forthcoming season, the Club will be in the possession of the

largest fleet in the Commonwealth.

Repairs, amounting to £100, represent a substantial expense, and members are exhorted to exercise every care in handling boats and oars, when much of this expenditure will be avoided.

At Perth, 4th May, 1929.

Regatta placed your Club at the head of the points competition, but, owing to Ballarat's victory in the Champion Eights, it was necessary that practically every remaining Senior event of importance should be won in order to regain the top position. Your crew's success in the Champion Fours reduced the advantage gained by Ballarat, and the achievement in winning the Senior Eights at Barwon and Ballarat assured your Club of the Premiership.

It is fitting here to express your great appreciation of the valued service rendered to the Club by Mr. J. M. Macfarlane, who, on Mr. Sloan's retirement from coaching, owing to his serious illness, took

charge of the Senior crews with such marked success.

In the Junior division your Club has also gained much success, although not actually the Premiership. The winning of eight Maiden and Junior events during the season, is we think, creditable, and the success gained in the first Junior Championship Eight an achievement of which the Club may be justly proud. We extend our congratulations to the Albert Park Club, who gained the Premiership in this division, and to the Essendon crew who rowed with such determination in the Championship race.
