The Fifty-first Annual Report

OF THE

To the Members of the Mercantile Rowing Club,

Gentlemen,

Your Committee has much pleasure in presenting to you the Fifty-first Annual Report.

Your Club may justly claim that the season 1930-31 was an historic season. It not only marked the entry of the Club into its second half century of history, but proved to be, in the matters of progress and achievement, a worthy successor to the many successful seasons experienced in the past.

In rowing, your senior crews, although defeated in the premiership, were successful in several races, the most outstanding being the winning of the Grand Challenge Cup at the Henley Regatta; and in the Junior division your representatives were again successful in winning the premiership.

To emphasise the splendid performances of your crews throughout the season it may be stated that a win was recorded at every regatta at which your Club was represented.

Your Club's social activities during the year under review were successful and appreciated by all. The Annual Dinner, which was again held in the Banqueting Hall, Melbourne Town Hall, was a most popular function. A very fine dance was also held in this hall on Boatrace Night and attracted an excellent attendance.

The position and prospects of your Club to-day enable us to anticipate with confidence many successful seasons in the future.

Finance.

The particulars of revenue receipts show that the amounts received for subscriptions, donations and entrance fees for Club races are less, but, notwithstanding, the progress of the Club has not been affected to any extent.

The next year will depend in a great measure on the co-operation and loyalty of the members generally, and particularly on the care exercised by the Committee in their disbursements.

A considerable proportion of the item, Repairs to Boats, Oars, Shed, is accounted for by accidents which might have been avoided by a little more care. It is desirable that members be watchful of the Club's interests in this connection.
