To the Members of the Mercantile Rowing Club,

Gentlemen,

Your Committee has much pleasure in presenting to you the

Fifty-second Annual Report.

Although your Club has not had the outstanding success of recent years its position as regards premiership honors can be considered quite satisfactory, inasmuch as it occupied third position in the Senior Division and second position in the Junior Division.

The performance of the Senior Eight in winning the double at the V.R.A. Regatta and the Henley Regatta was a fine achievement, and in the junior ranks the most outstanding performances were the winning of the Champion Junior Eights and the double at the V.R.A.

and Henley Regattas.

The Club's social activities during the year under review were successful and were appreciated by all. The Annual Dinner, which was held at the City Club Hotel, was a most enjoyable function and was attended by a large number of members. The Annual Ball, which was held on Boat Race Night in the Melbourne Town Hall, in conjunction with the Lord Mayor's Charity Fund, was a most popular function.

The membership of the Club has unfortunately shown a slight decrease and your Committee will greatly appreciate your co-operation in assisting to remedy this position. New members are assured of a

warm welcome and every attention will be given them.

Generally the Club is in a satisfactory position and the cooperation and interest of every member is necessary to maintain its prestige.

Finance.

It will be noticed that, due to the care exercised by your Committee, the amount due to the Bank of New South Wales and sundry creditors, which stood at £473 at the beginning of the season, is now £272, a reduction of no less than £201 for the season. This is certainly a very fine effort.

It would be a notable achievement on the part of members if this liability should be removed from the balance sheet altogether during

this season, and no efforts should be spared to that end.

Your attention is directed to the item, Repairs to Oars and Shed-£55, which is an extremely low figure considering the size of

your fleet.

The difficult conditions prevailing are reflected by the falling off of £20 in the amount received in subscriptions. Your Committee expects that this leeway will be made up during the coming season.
