FIFTY-FOURTH ANNUAL REPORT

Club House, Princes Bridge, Melbourne. 1st July, 1934.

To the Members of the Mercantile Rowing Club.
Gentlemen,—

Your Committee has much pleasure in presenting to you the Fifty-fourth Annual Report and Balance Sheet.

Your Club was represented at all the Regattas during the Season and finished runners-up in the Senior Premiership, winning the Gilby Cup at V.R.A. and the Senior Eights at Barwon, but in the Junior Division your Club was unsuccessful.

The Selection Committee this season has been concentrating on building up the maiden ranks, and the knowledge and experience gained by these crews should prove successful next season.

This season has been one of the most successful with regards to Club races, six different Club races being held, one of the most popular being the Seven-Mile Time Trial.

Your Club was well to the fore socially. A very successful Ball was held on Boat Race night, as well as a series of monthly dances. Lectures on Rowing were given by your President, Mr. A. L. Dobbie, and Dr. H. C. Discher.

FINANCIAL.

During the season the flooring in the shed was attacked by dry-rot, due to defective ventilation. The affected boards were replaced and the whole floor was relaid and treated with fungicide mixture. This entailed considerable expense, but the work has been faithfully done and your Committee is hopeful that there will be no more trouble of this nature. The "Repairs to Boats" item is still formidable, but members may congratulate themselves on the fact that the condition of the fleet is second to none on the river. The overdraft due to the Bank has been further reduced during the season, and now stands at £194. Members are thanked for the way subscriptions have been met and, in view of the Club's financial position, it will be appreciated if a ready response is forthcoming this season.
