The late
Mr. A. L. DOBBIE

THE death of the late Mr. A. L. Dobbie on 29th December, 1954, has been felt very deeply not only by all members of our Club, but also by everyone connected with rowing, and many beyond it, for Mr. Dobbie was a man who had interests in many walks of life and such were his character and ability that no one who was connected with him in the many phases of his activities can fail to regret his passing or be the poorer for it.

Mr. Dobbie joined the Club at the age of 19 in 1902. He was immediately prominent in active rowing winning Maiden Eights and Fours in the season 1903-4 and being selected, as a Maiden Oarsman, to row in the Victorian Crew at Brisbane in 1904. From then on he represented the Club in Senior Crews until he retired from competitive rowing in 1908. This did not, however, end Mr. Dobbie's active participation in the sport for he was prominent as a Coach for the Club and also for Scotch College for many years. He achieved the distinction of winning the Warehousemen's Challenge Races every year from 1903 to 1914 and until quite recently was to be seen on the river in the "President's" Four on Sunday mornings.

During these years Mr. Dobbie filled with distinction all executive offices of the Club and took a continuous and active part in the administration of the Club from 1904 until the time of his death. He was Secretary from 1904-6, on the Committee from 1906-7, Vice-Captain 1907-8, Captain 1908-19, Committee 1919-22, Vice-President 1923-33, and President from 1933.

Mr. Dobbie was prominent also in the administration of the Rowing Association and other bodies connected with the Sport. He represented Mercantile as a Delegate from 1905 to 1907 when he became an Elected Member. He held this position until 1937 when he was elected Vice-President and in 1954, shortly before his death, he was honoured by being elected President. Besides holding these various offices Mr. Dobbie was on the Executive Committee from 1929 to 1950 when he retired in order to make way for a younger man.

Mr. Dobbie's assistance and advice were available also to the Melbourne Amateur Regatta Association and from 1934 to 1954 he was on the Executive Committee of this Association which conducts the Melbourne Henley. He held also the office of President of the Old Oarsmen's Association, being elected to that position at the inaugural meeting in September, 1937, and holding office until his death.

Few men, if any, have given such long and valuable service to the Club and to rowing as did Mr. Dobbie and his services in the administrative sphere have earned him unqualified admiration and respect. But it is not for that reason that his loss is most deeply felt at Mercantile. To many members he was a staunch and life-long friend, and there was no member too new or too young to claim his interest and encouragement. None who knew him, even if only as "The President", could fail to appreciate his genial and kindly nature or to value his friendship and advice. With his passing the Club has lost a very valuable officer and all its members a loyal friend.

THE SEVENTY-FIFTH ANNUAL REPORT OF THE MERCANTILE ROWING CLUB

To the Members of the Mercantile Rowing Club:

Gentlemen,

Your Committee has pleasure in submitting for your consideration the 75th Annual Report and the Balance Sheet and Financial Statement for the year ended 30th April, 1955.

It is with the deepest regret that we record the death during the season of Mr. A. L. Dobbie who has been President of the Club for the past 21 years. Mr. Dobbie's services to rowing generally and in particular to your Club are well known to all members and are referred to more fully elsewhere in this report.

In exercise of the powers accorded to it under the Constitution, your Committee asked Mr. J. G. Sprigg to accept the office of President until the elections at the Annual General Meeting, being confident that the ability and enthusiastic leadership which he has shown as a member and executive official of the Club in the past qualified him well to hold the position so ably occupied for many years by Mr. Dobbie.

Your Club has again had a very successful season, winning the Junior and Lightweight Premierships and sharing with the Albert Park Rowing Club the honour of winning the Senior Premiership. Your congratulations have been extended to the Albert Park Rowing Club on this fine achievement with so small a number of members.

The closeness of competition for the Senior Premiership may be judged after considering that this pennant was in doubt until the Easter Regattas and only the defeat of the Albert Park four by your own crew at the Mildura and Wentworth regattas enabled the Club to secure the points necessary to share the Premiership. In the Junior and Lightweight classes, your Club managed to retain these pennants quite comfortably, but it must be noted that early in the season your Club lay second in all premierships.

While there has been very keen racing in four and pair oared senior events during the season, competition in the Senior Eights division has not been strong. At the Victorian Rowing Association Regatta your Club's crew was unopposed and at Henley, in November, retained the Grand Challenge Cup competing against a crew from Buckingham in Tasmania. The first Victorian competition was provided by the Albert Park Rowing Club at the Albert Park Regatta when your crew was successful by the narrow margin of one foot after a thrilling race. In subsequent races your crew showed the benefit of keener competition and improved steadily with convincing victories at Ballarat, Barwon and Henley, in March.

Your Club was also represented by a Senior Eight at the Mildura and Wentworth Easter Regattas, but was there defeated by Renmark

Rowing Club from South Australia. This defeat ended the Club's run of 26 consecutive victories in Senior Eights, an achievement upon which the members may look back with pride and satisfaction, and which, it is hoped, will be an example to the Club's senior crews in coming seasons.

While your Club predominated in eight-oared senior events, your crews were unsuccessful in four-oared races throughout the season and the Albert Park Rowing Club is to be congratulated on its continued success in these events.

In Championship events this year your Club was unsuccessful in pair and four-oared races, but was able to secure the three eight-oared events by convincing margins. These latter races were particularly thrilling in the middle distance where not more than a length separated the competing crews in each division at any time and it was only during the last quarter mile that your representatives were able to draw away from the opposition.

This season saw the running of two Melbourne-Henley Regattas, the latter in conjunction with the Moomba festival in early March at which time the regatta will be held in the future. The undoubtedly success of this change will, your Committee feels, help to popularise the sport. In both Henley Regattas, Mercantile had a number of successes and in the second regatta secured the Senior, Junior and Lightweight Eights and Maiden Fours. By their victory in the Senior Eights, the Club retained the Grand Challenge Cup for the sixth successive occasion.

Your Club's lightweights again made the trip to Sydney for the Metropolitan Regatta, but were unsuccessful in their efforts in the four-oared event entered. Those members who attended the Regatta were overwhelmed by the hospitality extended and trust that Mercantile will have the opportunity to reciprocate during the coming season.

The Australian Championships were held this year in Adelaide and resulted in a fine win for Western Australia. Your congratulations are extended to the Victorian crew which, though unsuccessful in retaining the King's Cup, rowed extremely well to finish second. Members will be proud to learn that Mercantile was again strongly represented in the crew.

During the season under review the British Empire Games were held in Canada. Australia was represented in the single and double sculls, coxswainless pairs, and fours, the last entry being a combination of the scullers and pair. It is pleasing to be able to record that Australia won all events except the single sculls. Although all competing oarsmen came from New South Wales, Victoria and your own Club were represented by Mr. R. W. Thursfield as manager of the rowing section and Mr. E. Kenny as assistant manager of the whole team. We heartily congratulate the team on its excellent performance.

Your Committee was pleased to extend to Mr. M. S. Williams your best wishes and congratulations on his appointment as President of the V.R.A. to succeed the late Mr. Dobbie.

It is gratifying to see the interest this year displayed by schools in their entry in competitive rowing for the first time in many years. This is a healthy sign and your Committee has endeavoured, where possible, to assist this move by making available boats, particularly for use at the High Schools Annual Regatta.

At Henley, in March, your Club was not able to enter a crew in the Lightweight Fours to compete for the Ladies' Challenge Cup, a trophy which has been held by the Club since it was first awarded

for this race four years ago. However, by winning the Lightweight Eight at the same regatta, your representatives became the first holders of the Perpetual Cup presented by The Old Oarsmen's Association for this event.

The Club's social activities for the year were again well patronised and much credit is due to the Social Committee, under the excellent direction of Mr. Deane Morgan, for the smooth organisation of these events.

A more detailed account of the Club's activities is submitted for your review.

Financial

This season your Club's finances have caused your Committee much concern. As shown in the Income and Expenditure Account we have completed the season with a surplus of £7, compared with £359 in the previous year. This is due in part to a substantial rise in expenses, particularly under the heading of repairs to boathouse and fleet and in part to a reduction in donations.

During the season the new practice eight "A. L. Dobbie" was delivered, the practice eight "S. C. Macrae" was completely over-hauled and the front part of the shed was re-blocked. These expenses, amounting in all to £868, have proved a severe drain on the Club's finances.

A disappointing feature of the Balance Sheet is the large amount of £128 for subscriptions outstanding. Your Committee feels strongly that those members in arrears are treating too lightly their obligations to the Club.

In order to maintain the Club's practice and racing fleet at its present high standard, heavy expenditure on new boats is inevitable over the next few years. Already several of the racing boats have seen a great deal of service. Although your Committee is reluctant to increase the subscriptions it must be apparent to all members on looking through the Balance Sheet that this may be necessary in the near future.

Members will notice the Trophy Order account appearing in the statement for the first time. The procedure now is that all trophies won by members are paid through the Victorian Rowing Association to the Club for distribution by the Club in the form of Trophy Orders.

Once again our thanks are due to those members who have assisted us by their generous donations, also to the small band of workers who have attended the working bees during the winter months and saved considerable expense for repairs.

The only change to our fleet this year is the addition of the A. L. Dobbie, a practice eight purchased from Geo. Towns. This craft has already proved useful for the initial training of our Senior and Junior crews and has also been used by our Maiden and Light-weight eights for racing.

It should be noted that the "S. C. Macrae" is not as yet completely ready for rowing, but your Committee has this matter in hand now and the craft should be available very shortly.

The Club sadly lacks a tub scull of any reasonable worth at the moment, but, unfortunately, the financial situation of the Club prevents your Committee from taking any practical steps in this direction.

Your Committee made the "Deane Morgan" available to the V.R.A. for the use of the Victorian crew in Adelaide this year and also hired the racing pair, "H. P. Shears", to Tasmania for the Champion Australian Pairs.

At this juncture it seems appropriate to repeat the request that members use the utmost care when handling our present fleet, as the cost of replacement and repair places a great financial strain upon the Club.

AUSTRALIAN CHAMPIONSHIPS

7th May, 1955.

The Australian Eight-oared Championship for the King's Cup was rowed at Port Adelaide on the morning of Saturday, 7th May. Conditions were perfect and a large crowd attended to see the events. All States were represented and the race resulted in a win for Western Australia by $2\frac{1}{2}$ lengths from Victoria with New South Wales 3 lengths away third. Tasmania, Queensland and South Australia followed in that order. The race was rowed in the fast time of 15 minutes 40 seconds.

Victoria was represented by D. Christie (Albert Park), Bow; M. T. Shaw (Albert Park), 2; J. W. Dartnell (Merc.), 3; W. O. Granowski (Merc.), 4; G. O. V. Manton (Merc.), 5; W. N. Howell (Banks), 6; A. C. Monger (Univ.), 7; B. J. Doyle (Merc.), Stroke; N. Hewitt (Merc.), Cox; N. W. Cairnes (Merc.), Coach; and C. B. Dawes (Merc.), Emergency. To the crew and coach we extend our warmest congratulations on a very creditable performance.

The Sculling Race for the President's Cup resulted in a convincing win for M. T. Wood, of New South Wales, from B. Green, of Queensland, and G. Hubbard, of Western Australia. Victoria was represented by D. Dudgeon, of Richmond Rowing Club.

We have also to congratulate Victoria's representatives in the Australian Pair-oared Championship on their comfortable win in this event. This crew, which came from the Albert Park Rowing Club, was R. B. Duncan (Bow), B. Dickson (Stroke), R. Trezise (Cox) and H. D. Duncan (Coach).
