of the

To the Members of the Mercantile Rowing Club:

Gentlemen,

Your Committee has pleasure in submitting to you the 77th Annual Report and Financial Statement for the year ended 30th April, 1957.

This year, the Olympic Year, has made history in Australian amateur sport, and in particular, Rowing has reaped the benefits which come from international competition. We are pleased to report that out of seven crews comprising the Australian team, five of those crews competed in the final events on Tuesday, 27th November. We congratulate all Australians oarsmen who comprised the team, and the members of those crews from other countries who won medals.

Whilst we did not achieve first place in any final event, our congratulations are particularly extended to those oarsmen who won minor placing on the final day. This Club was fortunate in being well represented in the Eight-Oared Eeven by the following members:—Messrs. B. J. Doyle (stroke), G. O. V. Manton (5), D. H. Boykett (2) and H. N. Hewitt (cox). Messrs. C. B. Dawes and J. Morganti were emergencies. Our congratulations are also extended to Mr. R. R. Aitken, coach of this crew.

Our last Annual Report indicated that whilst racing results had, in the main, been disappointing, we anticipated that a marked improvement would be seen during this season. Unfortunately, our expectations have not been achieved, and if anything, results have shown a slight decline when compared with those of 1955-56. One pleasing feature, however, is the enthusiasm that has been displayed by those members who have competed in Regattas, although the number of contestants has shown some reduction compared with last year's entries.

The Senior ranks have suffered the loss of quite a few of our experienced oarsmen, some of whom represented Australia in the Olympic Games, and as a result our Junior oarsmen have been moved into this higher classification. We are hopeful that the experience gained this year will place us in a stronger position for Senior rowing during next season.

A gratifying feature is the large number of Novice oarsmen who have been admitted to the Club during this season. Most of these members have entered keenly Regattas in the Novice, Maiden and Lightweight classes, and whilst successes have been few, they

have gained experience which we are sure will bring better results for the Club during next season.

The Senior Premiership was reinstated this year, and once again our congratulations are extended to Albert Park, who were successful in taking the pennant. We feel that our lack of success in this category was largely due to inexperience of many of our oarsmen who competed.

Our Lightweight and Junior Oarsmen were also unsuccessful in gaining sufficient points to attain success in either of these Premierships, and our congratulations are extended to Yarra Yarra and Corio Bay Clubs on their respective successes.

Whilst all members must agree that the above does not present a very gratifying position for the Club at the present time, a concentrated effort on the part of all members is one way of assisting your Committee to achieve some success during next season. Every member is urged to consider carefully this matter, and assist wherever possible so that the Club will once again rise to the top of Victorian Rowing.

During the year your Club has been well represented at all country Regattas, and to all our hosts during the past season your appreciation for their assistance and hospitality are extended.

This year introduced a new Regatta "Head of the Yarra" run by the Hawthorn Rowing Club as a time trial from Princes Bridge to the Hawthorn Club House. Although no premiership points were available for this competition, all competitors agreed that the event is one which must be encouraged so that future years will bring increased competition for this event. We congratulate Hawthorn on their organisation of this event, and look forward to a similar Regatta next year. This Club was successful in gaining, for one year, the perpetual trophy which has been made available for the club boating the winning crew.

Once again the activities of the Social Committee have been continued during the year, and our thanks are extended to Messrs. Garth Manton and Paul Harding, whose assistance has so much ensured the success of these functions.

Your congratulations are also extended to Mr. N. W. Cairnes, Secretary of the Australian Rowing Council and Course Manager for the Olympic Regatta at Ballarat, for his work in ensuring the success of this historic event. Undoubtedly, the attention to detail maintained by Mr. Cairnes, in conjunction with Mr. T. Rodda, Assistant Course Manager, was directly responsible for the high praise afforded to Australian Rowing by the International Olympic Officials. We thank these two Club members for their untiring efforts in this regard.

All Australians who officiated at the Olympic Rowing will also agree that the high standard maintained throughout the Regatta was greatly assisted by the experience and continuous guidance of Mr. Gaston Mulegg, President of the International Rowing Federation.

In conclusion, we are pleased to announce that Mr. L. S. Williams, one of our members, was appointed to coach Victoria in the King's Cup, which was held in Queensland this year, and the following members were selected to the crew:—Messrs. H. R. Frederico, D. Boykett, C. B. Dawes and J. Morganti.

A more detailed account of the Club's activities is submitted for your review.

Financial

Although the subscriptions were increased at the commencement of last season, your Committee is still concerned with the high cost of maintaining the clubhouse and fleet at its present standard.

Prior to the Olympic Games your clubhouse was repainted by a small band of willing workers, under the guidance of Mr. Deane Morgan, thus saving us a considerable amount of expense. Towards the end of the season, it was also necessary to replace a large section of the spouting before more damage occurred during the winter.

During this season we face heavy commitments both for the clubhouse and the fleet, as it has become necessary to re-floor the shower-room, which is at present leaking badly; and your Committee has placed on order a new racing four and racing pair, for delivery before the start of the season.

So as to help your Committee to meet these expenses, it would be appreciated if all members would endeavour to pay their subscriptions as early as possible.

Once again we are indebted to those members whose names appear in another section of the report for their generous donations and continued support of the Club.

The Australian Eight-Oared and Sculling Championships were rowed in Queensland on Saturday, 11th May, 1957, over the three-mile course. Both events were rowed as a first and final, as had been customary prior to last year, when heats and repechage heats were contested on the Olympic course at Ballarat.
