'If in the election of the Committee more than a total of two Junior Members are nominated and more than two in the ordinary course of the election be returned as elected to office, then the chairman of the meeting shall direct a total of not more than two Junior Members as elected, and those to be elected shall be those who lead amongst Junior Members in the vote for election to the committee, and the Junior Member receiving less votes than the two highest Junior Members in the vote shall be deemed to be ineligible for that particular election and the chairman shall elect an ordinary Adult Member or Members next on the number of votes received to fill the committee. The scrutineers in returning the result of any vote shall indicate the position as a guide to the chairman'."

5. To consider the following recommendation of the Committee:—

"That Section 8 (a) of the Constitution be deleted, and the following substituted:—

'Any member who has been financial for ten previous consecutive years, and does not desire to continue active membership may at the discretion of the Committee be elected an Honorary Member. Honorary Members shall have all the privileges of the Club except election to any Executive Office or seat on the Committee or the use of boats'."

EIGHTIETH ANNUAL REPORT OF THE

MERCANTILE ROWING CLUB

TO the Members of the Mercantile Rowing Club:

Gentlemen.

Your Committee has pleasure in submitting to you the 80th Annual Report of the Club and Financial Statements for the year ended 30th April, 1960.

Once again we are pleased to report that our results in rowing throughout the season have been quite successful, although not to the degree that we had originally planned. However, the overall position shows that we have been able to establish an enthusiastic team of young, well trained, active oarsmen, and we consider that we are now in a position to make a more determined effort to achieve our ultimate goal, namely, all three Premierships in one season.

We won a number of important races during the year, particularly in the Senior Division, and again won this Premrieship Certificate. This year the standard of senior competition was particularly high, and so that the maximum number of oarsmen could compete, the Victorian Rowing Association allowed composite senior eights to contest the early regattas of the season. We were fortunate in having our members rowing in two of these crews as well as our own senior eight.

This being an Olympic year, the incentive offered to our senior oarsmen was higher than usual, and although none were successful in gaining selection for Rome, it is gratifying to note that many of them were represented in the various Olympic Test Races which were held during the latter part of the season in Tasmania, New South Wales and Victoria.

The King's Cup squad was selected in December last year, three months earlier than usual, and the strenuous efforts of our senior crews were duly rewarded when Mr. R. R. Aitken was selected as coach of the Victorian crew and the following members included in the squad:—Messrs. W. S. Arnold, H. R. Frederico, G. A. McCall, G. M. Taylor and M. G. Tomanovits, with Master C. J. Newman as coxswain. Unfortunately the crew was not successful; full details of the race are given later in this report.

Following the Victorian selections, we formed a new Senior Eight, and coached by Mr. N. W. Cairnes, this crew was successful in winning a number of major races, including the Grand Challenge Cup at Henley on Yarra.

The Junior Division did not produce as many successes as anticipated, but we were fortunate in having a large number who rowed in the Maiden Class, and in many instances qualified for the Junior ranks later in the season. These oarsmen form the nucleus for our future plans, and we are hopeful that as well as gaining more successes in this class, they will move on to the higher grade later in the year and strengthen our Senior ranks.

You will no doubt appreciate that the competition in Junior rowing has been particularly keen, and through a determined, concentrated effort Hawthorn Rowing Club was successful in winning the Certificate. We congratulate them on their fine achievement, and hope that we will meet them again next season, not only in Junior but also in Senior rowing.

In the early part of the season many of our Lightweight oarsmen competed in the Junior Class races, and as a result our lightweight successes were fewer than our original expectations. However, we did gain the highest honours in this

class when our crew, stroked by Mr. P. Harding, won the Lightweight Four-Oared Test Race at Ballarat on 19th December, 1959, and subsequently represented Victoria in the Penrith Cup at Launceston in March last. The coach of the crew was Mr. W. L. Wallace, with Master D. Palfreyman as coxswain. Details of this race are given later in this report.

We are gratified to report that Messrs. N. C. W. Courtney, R. Negri and C. B. Penfold were selected to represent Victoria in the Interstate University Eights Race in Perth. At the time of writing this report the race had not been held, but we all join in wishing the crew every success.

Finally, your Committee congratulates all competitive oarsmen, their coaches and the coxswains on their fine achievements throughout the season.

Your Club was again represented in Sydney this year when an Open Eight and Senior Four both competed successfully at the Metropolitan Regatta on Saturday, 12th March, 1960. This is the first time for many years that we have been successful in a New South Wales regatta, and were more than pleased when the N.S.W. Rowing Association allowed us to bring the Kerr Cup to Victoria for display at our Annual General Meeting. The crews were:—

We are indeed indebted to the members of Sydney Rowing Club, who not only arranged boats and accommodation, but also provided entertainment for our members throughout their stay in Sydney.

During the year the usual regattas were conducted, and at the beginning of the season two additional V.R.A. metric regattas were included so that oarsmen, principally in the senior class, could enter in more competition before the Victorian King's Cup squad was selected. The results, as outlined later in this report, show that we were well represented in these two fixtures, as well as the normal regattas. The second annual Scotch-Mercantile Regatta was also held before the Head of the River, and again strong support was received from Clubs, the public and High Schools.

Hawthorn Rowing Club again conducted the Head of the Yarra Time Trial Race, and a large entry was recorded. Our congratulations are extended to those Hawthorn members who arranged and conducted this regatta.

On Anzac Day the Victorian Rowing Association held combination eight races, the proceeds from which were given to the Oarsmen's Ward at the Prince Henry's Hospital. A good entry was received, and we hope that this event will become an annual fixture on this day.

Our social activities were again arranged by a small group of members, and although fewer in number than last year, each fixture was successful. Our thanks are extended to Norman Cairnes, John Carr, Chris deGuingand, Paul Harding, Deane Morgan and Hubert Frederico, who made arrangements for each function. The prime reasons for these gatherings is for members to meet outside the Club, but their success can only be assured by your attendance.

During the year a considerable amount was spent on repairs to the Clubhouse, and repairs and additions to the fleet. Whilst our immediate requirements have been met, we refer you to our future plans, which are outlined later in this report.

Finally, our thanks for their hospitality and co-operation are extuded to the Committees of the various metropolitan and country regattas, who attended to our various needs when we visited their territories, and particularly the members of Yarrawonga, Mildura and Wentworth Clubs who, in addition, assisted in arranging accommodation, etc., for our visiting members.

A more detailed account of the Club's activities is submitted hereunder for your review.

Financial

The statements of account attached to this report once again disclose a small deficit after allowing £511 for depreciation in value of the Club's fleet, oars and equipment.

Membership during the year increased, with a consequent increase of the amount due for subscriptions. Members will note, however, the substantial balance due at the end of the season for subscriptions outstanding. Although past experience indicates that a substantial part of the balance will be collected, it must be pointed out that the apparent disregard by some members for their obligations to the Club adds considerably to the task of the Treasurer and Committee. Furthermore, it is no encouragement to those members who every year so readily support the Club with donations, and who in the past year have contributed no less than £252.

Expenses increased slightly, and your Committee cannot see how any reductions of consequence can be made under this heading, if the Club is to be maintained as at present.

During the year several boats were sold at a figure £53 below book value, and it is clear that with the higher cost of equipment, the depreciation deducted annually is insufficient to provide for fleet replacements, and that funds must be sought elsewhere.

Your Committee is faced with an immense task in trying to provide members with a first-class fleet and clubhouse on the present subscription level. If all members help by meeting their commitments promptly and supporting the Club and its functions at every opportunity, we hope that this, our main object may be achieved.

Of this total, 63 competed in regatta races during the season just completed.

During the year we admitted 68 new members to the Club, 51 of whom were Juniors, and in most instances competed in regattas during the season. The overall membership has increased by 24 only, because some older members have been written off for non-payment of subscriptions. The low percentage of

competitive oarsmen to the total membership is another noticeable feature, and all are urged to look out for new recruits.

Scotch-Mercantile Regatta

The second annual Scotch-Mercantile Regatta was conducted on the Henley course on Saturday, 26th March, 1960, and again a large entry from Clubs and Public and High Schools was received. In general, a high standard of rowing was witnessed by the spectators, and some very close finishes were recorded; in fact, the first heat of the Novice Eights was a dead-heat, and likewise the final of the Junior Fours. In the first instance both crews qualified for the semi-final, and the Junior Fours re-rowed their race as the last event for the day.

This year trophies were presented to each successful crew throughout the afternoon, and the Regatta Committee was pleased to welcome Dr. Jean Littlejohn, who made the presentation to the successful Junior Eight, Scotch College; and the Headmaster of Scotch College, Mr. R. Selby-Smith, who presented the Open Eight trophies. This race was also won by Scotch College.

As usual, a sub-committee was formed to handle all details of the regatta. and comprised Messrs. R. R. Aitken, D. H. Boykett, D. J. R. Morgan and W. L. Wallace from this Club, and Messrs. L. H. Christie, E. M. Davidson, R. G. Logie-Smith and R. S. Olsson from Scotch College, with Mr. J. W. Bradshaw as regatta secretary.

The programme comprised the same events as last year, but no entries were received for the Open Sculls, and as only one entry was received for the Senior Fours the event had to be cancelled. A comparison with our last report will show that quite a few changes have been made to our fleet, the most prominent being the purchase of a new racing four, which was christened "J. W. Beattie"; and the sale of the racing four "R. R. Aitken," the racing pair "G. T. Hastie" and the practice four "L. B. Weire."

In addition, we have purchased one new set of oars, re-purchased the set which was sold to the Victorian Rowing Association last year, and ordered a further set to be delivered in September, 1960. During the year it became necessary for a number of our racing oars to be transferred to the practice sets, and purchases to date have only been sufficient to cover these transfers. Our present position is that there is still a shortage of good racing oars, and the set on order will only temporarily relieve the situation.

Future plans for additions to and replacement of the fleet are, of course, governed by finance, but we are hopeful of providing a new racing four and another racing eight for portion of the coming season, and replacing portion of the tub fleet, including a tub scull, during the next eighteen months. These are our most urgent requirements, and will be followed by a racing pair and practice eight in that order.

Throughout the year we have carefully noted the condition of the fleet, and although some repairs are now necessary, we feel that generally members are taking more care when using the equipment. This is a good sign, and we certainly look forward to a continuance of this practice, and further improvement.

This year, for the first time for many years, we departed from standard oars, and the new set purchased for use by our senior crew were specially constructed with two inch extra outboard and seven inch blades.

Coaching

We are again indebted to those members who have unselfishly given their leisure time to the task of coaching crews and novice oarsmen. Boat House

Following our comments in last year's report, we are pleased to advise that the south-west corner of the clubhouse was relined during the winter, and a stainless steel sink with hot and cold water installed. We are now planning to paint this area and hang a small number of photographs on the walls. We hope that by so doing it will be made more comfortable for regular attenders and those members who only visit us occasionally.

In addition, we have improved the shower room by replacing the cast iron basin with a stainless steel sink. Due to unfortunate circumstances, we were forced to spend additional money on the shower room floor because all attempts on our part to make the area waterproof proved unsuccessful.

In addition to normal repairs, some new our racks have been built along the western wall of the boathouse, and we expect to provide additional storage space for our fleet and equipment during the coming season.

Our plans are to re-paint the committee room and the outside of the clubhouse, but before this task is commenced we propose to interview a colour consultant so that the best advantage can be taken of the new paint colours, both for appearance and serviceability.

You will recall that at last year's Annual General Meeting it was suggested that the present gymnasium be converted into a squash court, and the incoming Committee was directed to investigate the possibility of such conversion. We advise that this matter was fully considered, and the Committee decided that in view of our present building structure, the lease arrangements with the City Council and the financial position, the scheme is for the present impracticable.

Head of the River

This race was again held on the Barwon River on Saturday, 9th April, 1960. Although the weather conditions for spectators were unpleasant, the final was one of the best Public School races we have seen for many years, and was won by Geelong College by a canvas from Wesley College, with Scotch College a canvas further back in third place. Our congratulations are extended to the winning crew and their coach Mr. A. Bell.

We were again pleased to accommodate Scotch College in this Club during their training, and our thanks are extended to Laurie Christie (Coach of the First Eight), R. Logie-Smith (Captain of Boats) and Ron Roberts, all of whom co-operated with the Committee and other members in every way throughout the season.

Australian Championships

This year the Australian Championships were held on the Tamar River, Launceston, on 19th March, 1960, and because the Australian Amateur Rowing Council had decided that this year's King's Cup Race would be the eight-oared test race for the Olympic Games in Rome, the distance was reduced to 2,000 metres. The races were held late in the afternoon, and calm water with a slight tail wind made the conditions ideal for both spectators and oarsmen. Details of the races are as follows:—

KING'S CUP.—Western Australia took the lead at the beginning of the race, and maintaining a high rating, were able to withstand attacks from both Victoria and New South Wales. They went on to win by one length from New South Wales, with Victoria in third position. The Victorian crew comprised: H. R. Frederico (Mercantile), bow; J. G. Howden (M.U.BC.), 2; M. G. Tomanovits (Mercantile), 3; G. A. McCall (Mercantile), 4; W. S. Arnold (Mercantile), 5, W. N. Howell (Banks), 6; Paul Guest (M.U.B.C.), 7; G. M. Taylor (Mercantile), stroke; C. J. Newman (Mercantile), cox; and R. R. Aitken (Mercantile), coach. The emergencies were Peter Guest (M.U.B.C.) and P. Gillon (M.U.B.C.), with Mr. R. G. Harding (Yarra Yarra) manager of the squad. Our congratulations have been extended to the winners, who will be the Australian representatives for the eight-oared race at the Rome Olympic Games.

PRESIDENT'S CUP.—Although no Olympic test race was held for single sculls, this race was also conducted over 2,000 metres, and was won by I. Tutty of New South Wales, who led over the whole distance. The Victorian representative was P. Edwards, of Melbourne Rowing Club, who finished in third place.

PENRITH CUP.—Victoria took the lead at the commencement of the race, but after 500 metres were overtaken by Western Australia, who won the race for the second time in succession, with New South Wales and Victoria in second and third positions respectively. The Victorian crew comprised J. J. Wylie (Mercantile), bow; K. M. Hume (Mercantile), 2; A. M. Walker (Mercantile), 3; P. Harding (Mercantile), stroke; D. Palfreyman (Mercantile), cox; W. L. Wallace (Mercantile), coach; with L. Gallagher (South Melbourne) as emergency. Our congratulations have been extended to the winners.

State Championships

Senior.—This year the Victorian Eight-Oared Championships were conducted over 2,000 metres on the Olympic Games Course at Lake Wendoree, Ballarat, on Saturday, 19th December, 1959. Four crews competed, and some of the best senior rowing for some time was witnessed. So that oarsmen from all clubs would have the opportunity of competing and gaining selection in the King's Cup crew, the Victorian Rowing Association permitted composite crews to enter, and we were fertunate in having representation in three of the four entrants. The race was won by our crew, the members of which were: H. R. Frederico (bowl), C. C. Grant (2), M. G. Tomanovits (3), G. A. McCall (4), S. H. Newcomb (5), D. H. Boykett (6), W. S. Arnold (7), G. M. Taylor (stroke), C. J. Newman (cox), R. R. Aitken (coach), with Melbourne University in second place.
