

The Ninety-Second Annual Report

of the

Mercantile Rowing Club

To the Members,

Gentlemen,

Your Committee has pleasure in submitting to you the 92nd Annual Report and Financial Statements for the year ended 30th April, 1972.

It is very pleasing to be able to report that the Club has regained its place at the top of Victorian rowing, having won both the Senior and 1st Division Junior Premierships for the season, but both Melbourne University and Barwon proved to be too consistent in competition for the Lightweight Premiership.

It is appropriate at this point to make special mention of the fine job done by the Captain, Mr. J. Burford, and no doubt the results achieved by the Club this season are due to his untiring efforts. Now that he has retired, it is our task to follow his signposts which point the way ahead.

From the outset of the season it was quite obvious that the main task confronting the Committee was to embark upon an active recruiting campaign, this resulted in the Club winning a large number of Junior and Maiden races, including both the Victorian Junior Eight and Four-Oared Championships, a fact which augurs well for the future.

At this stage it is worth bringing to the attention of every member the importance of recruiting young oarsmen to our folds. Many of us have contact with young people who attend rowing schools, and it is important that we make a special effort to bring them down to the river and introduce them to club rowing.

Following the Victorian Championships rowed at Ballarat on 8th January, six members of your club were selected in the King's Cup Squad. They were Messrs. G. H. Boykett, D. G. A. Douglas, P. M. Guest, J. R. Harry, A. E. Maginn and D. Palfreyman, while K. Leach was selected to represent Victoria in the President's Cup. The Squad was coached by two members of your Club, Messrs. D. H. Boykett and P. Cayzer.

The King's Cup was won by New South Wales from Western Australia, who incidentally were stroked by former club member George Xouris, with Victoria in third place.

Following the King's Cup Regatta, the New South Wales crew was selected as the basis of the Australian Eight-Oared crew for the Munich Olympic Games and we extend to them our best wishes and hopes for a gold medal performance.

The Penrith Cup was again a triumph for Victoria and we congratulate the crew and their coach Mr. A. L. Gladman on a fine performance.

The President's Cup was won by New South Wales, with Victoria finishing a very creditable second in this event.

At the conclusion of this season several of the older members of the Executive and Committee will retire from active participation in the Club's affairs, and while they will always be available to help with advice if required, it is their profound hope that from the ranks of our Junior members there will arise new dynamic leaders who, through sincere and inspired service to the Club will re-establish a full measure of its glorious past.

Finance

The Club's Balance Sheet has been recast this year to incorporate the Assets and Liabilities of the Memorial Building Fund. The Memorial Club House appears as an asset at \$44,740, being the total expenditure on the building, including the fire alarm system and architect's fees. The share of Brighton Grammar School in this expenditure was \$9,177. The improvements effected by the School are the property of the Club, subject to the occupancy agreement expiring in 1979 and their value has been added to Accumulated Funds.

The Memorial Fund, being members' donations, stands at \$14,544. The Club's revenue for the year increased to \$8,175, which falls short by some \$800 of the figure upon which the Committee based its financial planning for the new Club House. Expenditure at \$8,470 exceeded the budgeted outgoings of \$8,000. In consequence there was a deficit of \$295 against a budgeted surplus of \$1,000.

The bank overdraft has, nevertheless, been reduced as planned. Donations since 30th April have ensured that the Club is ahead of its repayment programme with the bank which will mean that interest commitments in the forthcoming year should be reduced. Further donations which are tax-deductible would be welcome.

Certain items of expenditure increased sharply, particularly entry fees and boat transport. The deficit in entry fees is due largely to the Club's endeavour to enter as many crews as possible in an ever increasing number of regattas. Entries usually close well in advance and a certain amount of scratching is inevitable.

Your Committee is confident that with a careful control of expenditure and the full support by all members of the Club's social functions, we can provide \$2,000 per annum for boat replacement and \$1,000 per annum for overdraft reductions as planned.

In addition, members are being advised in a circular accompanying this report of a new "Tributors' Scheme" which your Committee hopes will provide a novel and stimulating way of supplementing the Club's revenue.

The Committee is greatly concerned at the high cost of new equipment which has escalated at an alarming rate during the past 12 months, and when it is realised that the Club's income is to all intents and purposes fixed, members will readily appreciate how serious this problem may become. This situation was further aggravated by large repair bills which were forced upon the Club after the "Bill Bradshaw" and "S. H. Newcomb" were extensively damaged when severe wind storms disrupted both the Morwell and Colac Regattas.

The only new boat purchased during the year was the "W. T. Morrison", a best and best coxed pair. This boat has a special removable section so that it may also be used as a coxless pair. Two new sets of racing oars were purchased during the season, one of these having been constructed especially for lightweight oarsmen.

The Committee wishes to express their gratitude to several of our older coxswains who, under the guidance of Mark Connolly, carried out extensive repairs to the hull of the Club's motor boat.

Again, emphasis has been put to crews, strokes and coaches on the proper care and maintenance of boats and oars, and regular maintenance by the crews racing and training in these boats is the only practical way in which the fleet can be kept in first class racing condition.




