The Ninety-Third Annual Report

of the

Mercantile Rowing Club

To the Members,

Gentlemen.

Your Committee has pleasure in submitting to you the 93rd Annual Report and Financial Statement for the year ending 30th April, 1973.

The Club has had a successful season despite a decrease in the number of events won during the year. Consistently good performances by our Senior Eight have been in the main responsible for the Club retaining the Senior Premiership. The Club again won the Victorian Junior Four-oared Championship. After a thrilling race in the final of the Victorian Senior Eight-oared Championship, the Club's crew narrowly lost to Monash University, to whom we extend our congratulations.

Special mention must be made of our Junior Eight, who, faced with rowing in a different boat in the final of the State Junior Eight Championship, rose to the occasion and acquitted themselves splendidly in a magnificent display of fighting spirit. The personal qualities and standard of watermanship displayed by this crew is an example of what we can expect in future years from men of this calibre.

Seven members of the Club were selected in the squads for the King's Cup and Penrith Cup. They were: Hubert Frederico, Ian Duthie, Mike Faulkner, John Harry, Adrian Maginn, Bruno Romanin and John Shanasy. The King's Cup was won by Western Australia, with Victoria a very creditable second. The Penrith Cup and President's Cup were both won by Victoria, and we congratulate them on their performance.

It is appropriate at this point to make special mention of the excellent job done by our Captain, Martin Owen, and it would be no exaggeration to say that the results obtained in the many and varied areas of the Club's activities have been largely due to his inexhaustible supply of energy and enthusiasm.

It would be only fair to say that, whilst our Maiden and Lightweight oarsmen have done as well as could have been expected this year, both squads have been lacking in depth, and this has been reflected in the premiership points the Club has achieved in these classes this season. A concerted effort will have to be made to recruit new members if we are to show an improvement in these areas next season. The Club must continue a progressive recruiting policy, for now is the time to lay foundations for our representation at the 1976 Olympic Games and the 1978 World Championships.

Looking back in retrospect, we have had our moments of high success and our disappointments, but, win or lose, there has been this in common with all the Club's crews — they trained hard, they raced hard, and they enjoyed their rowing . . . after ninety-three years this is still what it is all about.

On the evening of Sunday, 6th May, 1973, a fire broke out in the Clubhouse, with the result that the changing room, gymnasium and showers areas were destroyed and partial damage sustained by the clubroom and committee room. Prompt arrival and action by the Fire Brigade enabled the fleet of boats and oars to be saved. Unfortunately, much of the Club's history, which was displayed in the destroyed areas in the form of irreplaceable photographs and presentation oars, was lost. The Rebuilding Sub-Committee has the situation well in hand, and plans are being formulated for the Club to rise again, Phoenix-like, from the ashes. It is to be hoped that financial considerations will allow the Clubhouse to be rebuilt in such a way as to cater for the needs of members for many years to come.

Finance

The Income and Expenditure Statement at the end of this report shows a surplus for the year of \$1,267. This satisfactory result is due mainly to the very generous donations of members and the Ladies' Auxiliary.

Income from subscriptions is slightly less than last year. It is hoped that the current recruiting drive will help reverse this situation in the coming season. All members can assist in this important aspect of Club life by introducing new members as well as maintaining contact with members of their own vintage.

Total expenditure for the year is in line with the previous year. The reduction in boat freight costs to country regattas is the result of the purchase of a boat trailer by the Club. This was made possible by the generosity of the Ladies' Auxiliary, who donated more than \$1,000 for this purpose. There was a significant increase in unrecovered regatta entry fees. The two main contributing factors for this are, firstly, the increase in entry fees and, secondly, the number of crews which have to be entered well in advance of race day and are unable to start.

Your Committee is pleased to report that the family of the late Dr. Cooper have established the "R. A. Cooper Memorial Trust Fund". The income from this fund (capital \$2,500) is to be used to provide the annual trophy to be known as the "R. A. Cooper Memorial Trophy" for the best clubman. The balance of the income is to be applied to the purchase of equipment, preferably for older oarsmen and/or to assist in sending competing oarsmen interstate or overseas. The trust is reported on separately with the Club Accounts.

During the year the Club received a most welcome bequest from the estate of the late J. N. Robertson. We were also advised of a most generous bequest by the late W. G. Ross.

Donations to the Building Fund have continued and, together with the Club's reduction of \$1,000, have enabled us to keep a little ahead of the schedule required by the rank. This is just as well in view of the recent fire, which will require us to seek further funds to finance the necessary rebuilding. Our insurance will adequately cover rebuilding the old part of the first floor but will not cover the cost of rebuilding the ground floor which was not damaged. The operation of the "Tributors Scheme" is covered elsewhere in this report. The proceeds of this year's operations will be included in next year's accounts. The Scheme is an excellent way for older members to maintain their interest in the Club and at the same time encourage the younger members to win races.

Your Committee is confident that with the continued support of members the Club will be able to finance the rebuilding of the rear section of the Clubhouse and maintain a first-class fleet for competing oarsmen.

OBITUARIES

RICHARD AUSTIN COOPER

Richard Austin Cooper, familiarly known to members as "Doc", had a fairly extensive knowledge of rowing prior to joining the Club, as he coxed Melbourne Grammar Head of the

River First Eight Crews in 1902 and 1903.

Soon after joining Mercs. he was selected cox of our Senior Eight, which position he held for a number of years. Those were the days of stirring competition between Alec Sloan of Mercs. and the Donald Frothers of Albert Park. As a deep thinker of rowing in those days, young "Doc" saw much mert in the form and method of both crews, and years later when he commenced coaching he endeavoured to blend the leading points of both those crews into the crew he was coaching.

When increasing weight caused him to retire from coxing he turned to rowing and sculling. As a lightweight oarsman and sculler he competed at regattas for several years with varying

success.

It was, however, as a coach that we discovered the real brilliance of the former coxswain. He had many successes over a long period, but unfortunately his professional duties considerably reduced the number of crews it was possible for him to coach.

After retiring from active coaching, he spent much time assist-

ing a number of less experienced coaches.

"Doc's" father was a Mercs. member for many years, and now his passing terminates the association of approximately 80 years of the Cooper family with this Club.

"Doc" was a great Clubman and a generous supporter of Club affairs. He was a regular attendant at regattas on the Yarra,

and also for many years at leading country regattas.

Rowing in general, and Mercantile in particular, can ill afford the loss of such a noted authority on rowing.

ALBY LINDBLADE

With the passing of Alby Lindblade our last remaining link with those who rowed and raced in the last century was severed.

Before moving to their own boathouse in Hawthorn, Scotch College rowed from Mercantile, and public school rowing was confined to fours. It is on record that during the 1898 Rowing Season, Alby was a member of the Scotch College crew which won the Public School Fours.

He won his Maiden Eight at Ballarat during the 1899 rowing year, and continued winning races with Mercs. until 1912, when he retired from active rowing. This versatile oarsman also won

a number of sculling races.

Many crews were coached by him until pressure of business made it necessary to withdraw from this side of the sport.

A great Clubman, he was keenly interested in, and supported, all Club activities. Failing health during recent years prevented him from visiting the Clubhouse and he was not known to many of our younger members.

We regret the passing of this valuable member.

WILLIAM GORDON "STONK" ROSS

Mercantile lost a stirling member in "Stonk" Ross, who passed on during mid 1972 after a short illness.

"Stonk", possessed of a quiet and charming personality, gathered a great many friends at Mercs. and along the river bank. In his heyday he was a powerfully built athlete and a most successful competitor, tough and fiercely determined in the boat, where he was usually seen in the 6 seat.

He was a member of the 1926 and 1927 Scotch Eight that won the Head of the River, and a Victorian representative in the 1939 King's Cup race in Brisbane.

As Club Captain, "Stonk" was an inspiration. His term of office at the helm won him praise for his leadership and for the manner in which he received most harmonious support of the members.

"Stonk" joined the R.A.A.F. at the outbreak of World War 2 and was a No. 1 course navigator. Whilst serving with 38 R.A.F. Squadron in "Wellington" bombers in the Middle East he was awarded the Distinguished Flying Medal.

After discharge from the R.A.A.F., he established a grazing property at Dunkeld, where he conducted several successful stud enterprises. He had an uncanny knowledge of stock and was a splendid horseman.

Further interests in which he held executive positions were the Dunkeld R.S.L., Swimming Centre, Polo-Cross, Fire Brigade and the Grampians Golf Club.

Some how he managed to find time to sail in the summer months.

His great love was rowing, and few would deny that he was a great Mercantilian.

PETER SCANES

Peter Scanes, who was tragically killed in a road accident last April, joined the Club in January, 1972, shortly after his arrival from London, where he had been a member of the Ouintin Boat Club.

He found a seat in the Maiden Eight almost at once and won several events in this crew. He subsequently was selected for the Lightweight Senior Eight, and this crew represented the Club at the State Championship.

This season his interest turned to sculling, and he was often to be seen training in his racing shell.

The Club has lost a cheerful, humorous and likeable young man, and we extend our deepest sympathy to his family in their loss.
