The experience gained during this season should enable us to make a good start and lay solid foundations for our second hundred years; the objective of course being to surpass the successes of our first hundred.

CAPTAIN'S REPORT

To the Members,

Your Committee has pleasure in submitting the 100th Annual Report and Financial Statement for the year ending 1st May, 1980.

With a little hindsight, there is no doubt that the season just passed could have been better, as we are all well aware.

The season opened with Mercantile winning the Winter Premiership and receiving a cheque form the regatta committee for \$100 towards the cost of our new pair, which at the Christmas party was christened the "H.R. Frederico" by Julia and Libby Frederico.

With a good start from the rowing point of view; as we moved towards the spring regattas, the extensive winter training program seemed to be paying off in several areas for the Club. We boated crews in the spring regattas in Senior, Junior and Maiden events with good winning chances. The hard work put in by newly appointed lightweigh coach, Marty Owen, was also paying dividends as the members of the lightweight squad won all the Open Eight and Four-oared events at the early regattas and it really did look as if we were on the way to possibly winning all premierships. With David Douglas' return to competitive rowing and its associated training commitments, it became obvious that he could not continue in his capacity as Chairman of selectors and at the November committee meeting he resigned and Marty Owen took up the position.

At the World Championships in Bled, Yugoslavia in September we were represented by Andrew Withers in the Eight, Steve Shirrefs and Alec Sloan in the coxless pairs, and David Palfreyman as coach of the womens four. The eight finished fourth (having beaten the Bronze and Silver medalists in winning their semi-final), the womens four were fifth and the first western national across the line and the coxless pair unfortunately did not make their final. Andrew Withers and David Palfreyman have achieved reselection as our representatives at the 1980 Olympics.

It became obvious in the last few regattas before Christmas that we were well on the way. Steve Shirrefs and Alec Sloan were successful in the coxless pairs event at the Ballarat regatta and in winning were the first Mercantile small boat to beat Monash for some years. Later that same day our Senior Eight were also successful. A week later we also had big wins in the Maiden eights and Maiden fours, and for the first time in three years, our lightweight eight were successful in defeating Melbourne University.

Our recruiting program was coming along well and things were looking promising for the Christmas regattas and the more important regattas later in the season. Our Junior eight was successful at Nagambie and Yarrawonga. The lightweight four won Junior fours at Nagambie and our rapidly improving youth four dead-heated with our lightweight four just 6" behind Yarra Yarra at Yarrawonga.

Upon our return from the Christmas regattas, it was with horror that we found that the bowman of the Junior eight was in fact, ineligible, and the crew, was of course, disqualified. Despite this setback, things still looked promising. In the middle of January, the first of the Olympic selection trials was held in South Australia and to our dismay we found that our Senior oarsmen were left far behind the oarsmen of South Australia and New South Wales.

At the first set of State championships, Mercantile was successful in the youth fours, the margin being seven lengths over Banks with our No. 2 crew in third place. In the Senior eights, Mercantile was a hot favourite to win for the first time in many years. Unfortunately, Monash, after a very fast start, were never headed and defeated our crew by just over a length. The lightweight eight championship was awarded on a row-over to Melbourne University due to the fact that our successful pre-Christmas eight had been decimated by illness and work commitments.

The second championship regatta was a two-day affair and also the third Olympic selection trails; and it was indeed a black weekend for the Club with our only success coming from our Maiden four. The youth eight, comprised primarily of the two fours who had competed so well just two weeks before was beaten by Melbourne University, and our Junior four was also well beaten. As if the weekend's results were not bad enough, I am sure you will all remember the results of the accident to the boat trailer on the way home from Ballarat, as a result of which approximately \$10,000 damage was done to our equipment. During the period immediately following the accident, the Club operated under extreme hardship, and it was only due to the generosity of two or three other clubs that we were able to continue. In particular, offers of help from Yarra Yarra and Richmond, reminded us that although we compete to win on the water, there is certainly a bond of friendship among the clubs along the river bank.

Our Junior eight competed in Tasmania very successfully and we are grateful to the many people in Tasmania who once again showed such great hospitality to our oarsmen during a very pleasant but hectic four days in Hobart in February. Upon its return the crew was successful in winning the Intermediate Section of the Head of the Yarra and it was felt that the crew had good potential to do well with Victorian and Australian championships coming up in March. In the lead up races however, they were not able to keep up the good work and were successful only at the Barwon regatta. They came second in many events to a crew from Banks, including the Victorian titles which were held a week before the Australian titles.

The National regatta held many high and several quite low performances for the Club. The efforts of Andrew Withers, Alec Sloan, David Douglas, and Steve Shirrefs in coming a very close second. Second in the coxed four was considered by all to be a good one, and later that day when those same four oarsmen, without the weight of the coxswain on board, won the coxless four title and in so doing became the first all Mercantile crew to win an Australian Open Championship since 1966, the Mercantile supporters were absolutely jubilant. The "icing on the cake" came the following day when those four oarsmen were the bow four of the victorious Kings Cup crew. While all this was going on, our Junior eight finished a disappointing fourth, and our Youth four, who had been so successful earlier in the season, also were a disappointing fourth. The effort of Lyall McCarthy and Mark Conolly in being so close in the lightweight pair without cox final is also worthy of comment. Undoubtedly the most improved lightweight oarsman in the Club, Simon Cook, showed his true merit in the Nationals. Simon started the season not being good enough to win the Maiden sculls, and finished the season a very close second to Mick Smith of Drummoyne in a field of twenty-odd lightweight scullers.

With four regattas of the season to go, your Club was leading in the Club Championship, the Junior Premiership and the Lightweight Premiership. It must go on record that a very disappointing performance by both the Club administration and the oarsmen let those three important titles slip away from us.

I believe valuable lessons have been learned by this year's, and, hopefully by next year's administration. The best, from a rowing point of view, is most certainly there, if the one hundredth year of Mercantile is to be successful in many areas both on and off the water.

Before closing this report, it would be remiss of me not to thank the members of the Club administration for their efforts throughout the year, in particular Marty Owen, who gave a great deal of his time to Club administration over and above the time he gave to coaching our elite lightweight oarsmen through a very heavy training program. Phil Ainsworth (until he went overseas in January) and David Pincus should also be thanked for their hard work as Club Secretary, and also Jeff Lawrence and Andrew Guerin for their efforts during the season. Ted Sorani also deserves mention for his work in the gym area and his services to the "Sauna Club". There are many other members of the committee whose efforts ran hot and cold throughout the year, and thanks are conveyed where thanks are due.

Our current return as a force in rowing can continue only with the greater support and involvement of all members.

RECRUITING AND COACHING REPORT

COACHING:

Over the past season there has been a marked increase in our regatta successes. This is largely due to the fact that we have been able to provide our crews with coaches who have shown the skill and enthusiasm necessary to lead our crews to those regatta successes.

The Senior men began the season under Martin Tomanovits, however, he was forced to resign because of business commitments and Peter Philip took up the reigns for the remainder of the season. Marty Owen most ably led the lightweight group and had to endure a most frustrating season plagued with dropouts for varying reasons including illness to more than one crew member. We also extend our thanks to the following members who have given considerable time and effort to the coaching of our other crews during the season under review : Roger Wilson, John Burford, John Nickson, Peter O'Brien, Mike Manley and Andrew Guerin.

RECRUITING:

Again the Club was successful in recruiting a number of Junior and Schoolboy members. The recruiting sub-committee headed by David Douglas once again organised the recruiting night in early September. A number of films were shown and the Mick Williams Combination Fours were raced in conjunction with this function.

Members are again reminded that recruitment of these oarsmen is wasted if we cannot provide members to organise and coach them.

BOATHOUSE AND EQUIPMENT REPORT

It is pleasing to report an active season in this area with a large amount of renovation work having been undertaken.

BOATHOUSE:

During the season the task of painting the exterior of the Boathouse was completed, while inside many of the pictures damaged in the 1973 fire were renovated and more gym equipment was constructed. The continuing work of Mrs Cairnes in restoring these damaged pictures, and also Ted Sorani in maintaining and building gym equipment is greatly appreciated.

EQUIPMENT:

A substantial amount of work was completed on the trailer and a number of the boats, but unfortunately some of this work was in vain. On Sunday February 3rd, our fully laden boat trailer was involved in an accident whilst returning from Ballarat causing serious damage to the trailer and many of the boats. Although the financial burden of the accident was borne largely by our insurers, it compounded a pre-existing shortage of boats into a nearly complete inability to satisfactorily boat our crews.

The Club purchased a new convertible racing pair, the "H.R. Frederico", which proved to be an excellent craft. The Ladies Auxiliary kindly donated a new outboard motor which enabled, following repairs to the other motor, the availability of two working motor boats to become a reality.

The Club has ordered three new racing pairs and a set of blades for delivery next season. The emphasis placed on small boat racing by the Australian selectors has been the major factor behind the rapid change in the types of equipment being purchased.

OBITUARY - J.G. WILLIAMS

Despite his death at a comparatively young age, John Williams had been associated with Mercantile for more than forty years. Son of the late Michael Williams (a former Vice President of the Club and President of the Victorian Rowing Association), John first joined Mercantile as a coxswain in 1937 and steered the Clubs' successful Maiden Four at Henley of that year.

During the latter years of the War, he showed considerable promise as both an oarsman and sculler and was a member of the Clubs' first post-War Senior Eight. In 1947, John was emergency for the successful Victorian King's Cup crew in Perth. The following season he rowed in the stroke seat of the Mercantile Senior Eight and subsequently concentrated on sculling. In 1949, John won the Victorian Sculling Championship and as Victoria's representative finished second to the legendary Merv Wood in the President's Cup.

Whilst just short of league standard, John was also a footballer of great ability and became a regular member of the now defunct Brighton side, when that team was a power in the Victorian Football Association.

A successful business man, he was both a member of the Melbourne City Council and a leading publican, whilst still in his early twenties.

During his long illness, John Williams showed tremendous courage and until shortly before his death, he was a visitor to the Club whenever his health and presence in Melbourne permitted.

After his valiant struggle, members were saddened to learn of the death of this great Mercantilian in Queensland on 4th May, 1980.

OBITUARY - KENNETH B. POPE

Ken was a successful Junior oarsman in pre-war years and retained his interest and activity on his return from active service in the Middle East and South Pacific.
